

Moojo Free Instant Payment Terms & Conditions

What is the Promotion about?

This Promotion (the “Promotion”) allows selected new Moojo customers who comply with these Terms and Conditions (“Terms”) to get the Instant Payment fee for the first Instant Payment refunded.

You will only be rewarded if you meet the criteria in these Terms, so please keep reading to find out how the Promotion works.

This Promotion runs from October 26, 2022 until November 30, 2022. We call this the “Promotion Period”.

You must complete all the criteria during the Promotion Period. If you do not, you will not receive a Reward.

Who is eligible for the Promotion?

This Promotion is open to new Moojo customers who are not yet verified for Moojo’s Instant Payment product and are officially registered in Germany.

If you are currently a Moojo customer, or have been a customer that has been verified for Moojo’s Instant Payment product before this promotion, you are not a new customer and therefore not eligible for this promotion.

What do you need to do to get the fee refunded?

To get the refund, you must sign up to the Moojo app. You need to successfully complete and pass our onboarding process and fill out your personal profile information completely in the app. You need to create an invoice via our app and request an Instant Payment. This means that:

- You must get verified for Moojo’s Instant Payment Product by our product partner aifinyo for the first time. If you have previously been verified for Moojo’s Instant Payment product, you will not earn a reward.
- Your invoice needs to be approved and verified by our product partner aifinyo.
- Successfully completing and passing our onboarding process means fully completing that process, providing the information we require, passing all our onboarding checks, and having your account opened by us. If you do not fully complete this process, or if you do not pass our checks, you will not earn a reward.

- You must successfully complete and pass our onboarding process and fill out your personal profile information completely. This also includes your tax or VAT number
- You must qualify as a German freelancer by adding your tax number or VAT number to your personal profile
- You must create an invoice via our app and request an Instant Payment via the Moojo app
- The offer is limited to 100 customers
- The offer is covering up to €150 Instant Payment fee amount per Instant Payment case

What other legal information should you know?

1. This promotion is limited to 100 customers.
2. The promotion covers up to €150 Instant Payment fee amount per Instant Payment case.
3. We may, at our sole discretion, determine whether you have complied with these Terms, or suspend, terminate or change these Terms without notice.
4. These Terms are published in English and any translation is a courtesy translation only. This means you cannot derive any rights from any translated version and only the English version can be used in legal proceedings.
5. The refund will be paid to your bank account that you add to your personal profile within your Moojo customer account.
6. Refunds will be paid latest within 10 working days after the end of the Promotion Period.
7. To be eligible for an Instant Payment fee refund, you must comply with these Terms and all other terms and conditions that apply to your Moojo account.
8. If we believe that you have engaged in any fraud or material abuse of this Promotion we may in our sole discretion take any actions we see fit in the circumstances.
9. These Promotion Terms are an agreement between you and the Moojo entity which provides you with your account. If you have any questions or complaints about this Promotion, you should contact Moojo via the in-app chat or at support@getmoojo.com.
10. This Promotion is governed by German laws and the courts of Berlin have exclusive jurisdiction to hear any dispute related to the Promotion.
