

Moojo25 onboarding bonus campaign Terms & Conditions

What is the Promotion about?

This Promotion (the “Promotion”) allows selected new Moojo customers (freelancers & creators) who comply with these Terms and Conditions (“Terms”) to earn a welcome reward of €25 (the “Reward”) when they sign up to Moojo using a promotion code provided by Moojo.

You will only be paid the reward if you meet the criteria in these terms, so please keep reading to find out how the Promotion works.

This Promotion runs from November 23, 2022 until December 31, 2022. We call this the “Promotion Period”.

You must complete all the criteria during the Promotion Period. If you do not, you will not receive a Reward.

Who is eligible for the Promotion?

This Promotion is eligible for new Moojo freelancer customers that register with Moojo for the first time and who live in Germany.

If you are currently a Moojo customer, or have been a customer or started the sign up process in the past, you are not a new customer and therefore not eligible.

What do you need to do to earn the Reward?

To earn a Reward, you must sign up to the Moojo app using the promotion code provided by Moojo. For the 25€ bonus you need to successfully complete and pass our onboarding process and fill out your personal profile information completely in the app. You need to create an invoice via our app and send it to your client via the Moojo app. This means that:

- You must sign up to the Moojo app for the first time. If you have previously had a Moojo account, or have previously started but not completed the account opening process, you will not earn a Reward.
- As mentioned above, you have to use the unique promo code provided by Moojo. If you do not use this code - for example if you sign up using the normal / different account opening process to our app without this code, or if you sign up using a link or code that is for another promotion - you will not earn a Reward.

- Successfully completing and passing our onboarding process means fully completing that process, providing the information we require, passing all our onboarding checks, and having your account opened by us. If you do not fully complete this process, or if you do not pass our checks, you will not earn a Reward.
- You must successfully complete and pass our onboarding process and fill out your personal profile information completely in the app. This also includes your tax or VAT number.
- You must qualify as a German freelancer by adding your tax number VAT number to your personal profile.
- You must create an invoice via our app and send it to your client via the Moojo app.
- This client has to be a real client with which/whom you have an existing contractual relationship.
- You need to have performed either a service or delivered a product to your client before that the invoice is based on.

You will not be paid a Reward (or may have a Reward that has been previously paid reversed) if you reverse one of these steps after taking it.

What other legal information should you know?

1. We may, at our sole discretion, determine whether you have complied with these Terms, or suspend, terminate or change these Terms without notice.
2. These Terms are published in English and any translation is a courtesy translation only. This means you cannot derive any rights from any translated version and only the English version can be used in legal proceedings.
3. The Reward will be paid to your bank account that you add to your personal profile within your Moojo customer account..
4. Rewards will be paid latest within 10 working days after the end of the Promotion Period.
5. To be eligible for a Reward, you must comply with these Terms and all other terms and conditions that apply to your Moojo account.
6. If we believe that you have engaged in any fraud or material abuse of this Promotion we may in our sole discretion take any actions we see fit in the circumstances.
7. These Promotion Terms are an agreement between you and the Moojo entity which provides you with your account. If you have any questions or complaints about this Promotion, you should contact Moojo via the in-app chat or at support@getmoojo.com.
8. This Promotion is governed by German laws and the courts of Berlin have exclusive jurisdiction to hear any dispute related to the Promotion.
